**Four Points Aero Services, LLC Completes the Acquisition of West Star Aviation's Dallas Maintenance Facility**

Company, is pleased to announce the acquisition of the assets business and operations of West Star Aviation – Dallas, located at Dallas Love Field, (DAL). The location is an authorized service center for Embraer, Cessna Citation, Rockwell Collins and others. The business has provided maintenance services for well over ten years, the last six as West Star. Four Points Aero will continue to provide service and expertise in supporting and maintaining the Beech King Air Series, Hawker Series, Falcon 50, 900 and 2000 series aircraft, Pilatus Series and various other turbo-prop and jet aircraft. Four Points Aero also has capabilities to perform avionics systems upgrades and repair. In addition, Four Points will provide AOG (aircraft on ground) support for aircraft within a 250 mile radius of Dallas Love Field. Vehicles are standing by and equipped to support this maintenance function. As of August 2013, Four Points will have the capabilities to provide engineering, design and other functions necessary for interior repair, modifications, upgrades as well as full interior modification.

Waypoint Aero Holdings will ensure that the outstanding tradition of quality airframe, engine and avionics maintenance and repair that its customers have come to expect and deserve will continue, along with the enhancement of these services and new services to be added.
